**INVITATION TO BID FOR THE HAULING SERVICES OF WASTE MATERIALS FROM DIFFERENT ISLAND BARANGYAS TO MORONG SANITARY LANDFILL, MORONG RIZAL**

The Municipal Government of Binangonan through the General Fund intends to apply the sum of One Million Eighty Two Thousand Seven Hundred Pesos (Php1,082,700.00) being the Approved Budget for the Contract to payment under the contract for the Hauling Services of Waste Materials from different Island Barangays to Sanitary Landfill, Morong Rizal. Bids received in excess of the ABC shall be automatically rejected at Bid Opening.

The Municipal Government of Binangonan now invites bids for the Hauling Services of Waste Materials from different Island barangays to Sanitary Landfill, Morong, Rizal. Bidders should have completed, within (2) years from the date of submission and receipt of bids, contracts similar to the projects. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using non discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizen/sole proprietorships, partnerships, or organizations with at least sixty (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the Municipality of Binangonan through the BAC Office and inspect the Bidding Documents at the address given below starting October 02, 2020 from 8:00 am to 5:00 pm.

A complete set of Bidding Documents maybe purchased by interested bidders at BAC Office upon payment of a non-refundable fee in the amount stated in the revised IRR of RA. 9184.

The Municipality of Binangonan through the Bids and Awards Committee (BAC) will hold a Pre-Bid Conference on October 12, 2020, 02:00 pm. at Municipal Annex Building of the Municipality of Binangonan which shall be open to all interested parties.

Bids must be delivered on or before October 26, 2020, 02:00 pm. at the Municipality of Binangonan BAC Office. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.1 of the Bidding Documents.

Bids will be opened in the presence of the bidders' representatives who choose to attend at Municipal Annex Building at exactly 02:00 p.m. of October 26, 2020. Late bids shall not be accepted.

The Municipal Government of Binangonan reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
